## VENDOR VILLAGE APPLICATION

The Dearborn Homecoming Festival Vendor Village is an artisan and community resource market dedicated to highlighting the creativity and philanthropic work of makers and non-profits from the greater Dearborn area.

Carefully review the information and complete the enclosed application by **April 1, 2026**.

Because space is limited, vendors are encouraged to submit completed applications as early as possible. Applications submitted after the deadline will not be considered.

**NOTE** - Selection of Vendor Village applicants is determined by a festival committee. Priority will be given to artisans and Dearborn-area non-profits that most widely appeal to the Dearborn Homecoming Festival audience. Not all businesses / organizations will be selected for the Vendor Village. Thank you for understanding.

Selected vendors will be notified via email by no later than April 10, 2026. A payment invoice will be sent upon selection.

# PARTICIPATION DETAILS & FEES

Vendors must commit to all three days of the festival throughout the entirety of festival operating hours. The festival will take place rain or shine.

Your vendor fee includes one 10x10 tent (with one back wall), one 6 ft. table, two chairs, and a dedicated vendor wifi network. All additional items must be provided by vendors.

If requested, electrical hookups will be available for an additional fee of \$50. Please note - due to site restrictions, we are unable to provide electricity to every vendor who may request it. Electrical hookups will be offered on a first come, first served basis based on the date your application is received.

# VENDOR VILLAGE RULES & REGULATIONS

1. Vendors must remain within their assigned booth space. You will not be permitted to stroll throughout the festival grounds to sell items or distribute information.
2. All on-site vendors require an I-Chat authorization from the Dearborn Police Department (further instructions will be sent upon selection).
3. Each assigned space must be left in the same condition in which it was found. All waste must be disposed of properly. If not, the vendor will be responsible for compensation to the City of Dearborn in the amount required to return the area to its original condition.
4. Booth assignment is up to the discretion of Dearborn Homecoming Festival organizers.
5. The decision to cancel Dearborn Homecoming Festival due to inclement weather will be made by the City of Dearborn. If canceled, the City of Dearborn will not be held responsible for any cost(s) or loss of potential earnings incurred by operators. However, in the event of a full cancellation of the Dearborn Homecoming Festival ahead of the festival start date, participation fees will be refunded.
6. Vendors will have between the hours of 9 a.m. - 11 a.m. each morning of the festival to set up their booth space. NO vehicles will be permitted to move through festival grounds past 11 a.m. After 11 a.m., a vendor transport cart service will be provided by the festival to move supplies to and from the vendor parking lot and your booth. Failure to comply with this rule may result in the immediate forfeiture of your vending privileges without refund.
7. If you plan to host a raffle at your booth, please note that all raffles must be approved by Dearborn Homecoming Festival organizers in advance. A copy of your State of Michigan raffle license must be provided.
8. No fresh food or drink vendors will be permitted in the Vendor Village (prepackaged items intended for off-site consumption MAY be permitted at the discretion of festival organizers). If you are a culinary vendor, please explore the Food Truck Corridor options as opposed to the Vendor Village.
9. The City of Dearborn has established an exclusive community partnership for bottled water sales at Dearborn Homecoming Festival. All bottled water sold or given away at the festival MUST be purchased through the City of Dearborn. To avoid price gouging, all water sales must be capped at \$2 per bottle. Pricing info will be provided upon selection.
10. Dearborn Homecoming Festival offers exclusive onsite ice sales to vendors. Pricing info will be provided upon selection.
